Dear Ms. Dortch:

On Tuesday, July 28, 2015, the parties listed on the Attachment hereto, representing various rural telecom operators and associations, met with Federal Communications Commission (the "Commission") staff as listed on the Attachment to discuss concepts and other specific plans for the updating of existing universal service cost recovery mechanisms.

In particular, we discussed the opportunities and challenges presented in attempting to implement a methodology that would provide for recovery of previously incurred costs through existing mechanisms and network costs incurred in the future through a new recovery mechanism. We discussed the need for carefully designed transitions between old and new mechanisms, the need for thoughtful approaches to setting clear and predictable rules in new mechanisms that will take account of the interaction of old and new mechanisms and also provide reasonable opportunities for cost recovery in high-cost areas going forward, and ultimately the need to ensure that consumers under any mechanism have the choice to adopt voice or broadband that will be reasonably comparable in price and quality to those services as available in urban areas.
